Subject:- Petition of UjwalRai Moreshwar Joshi against Maharashtra State Electricity Distribution Co. Ltd. for non-compliance of Electricity Ombudsman Mumbai's Review order, Ref. Case No. 14/2018 dated 08/10/2018.

UjwalRai Moreshwar Joshi has filed Petition on 09.01.2019 Petition against Maharashtra State Electricity Distribution Co. Ltd. for non-compliance of Electricity Ombudsman Mumbai's Review order, Ref. Case No. 14/2018 dated 08/10/2018.

The main prayers of the Petitioner are as under-

- 1) *As prayed before The Honourable Electricity Ombudsman, Mumbai. Copy enclosed for your ref.*
- 2) *Non compliance of MERC Regulation of Not Conducted IGRF Hearing. Suitable penalty be imposed on the concerned officers of IGRC of MSEDCL.*
- 3) *Serve Punishment to those officers of MSEDCL for non compliance of the orders of Chief Engineer Bhandup Zone, for resolving customer grievances.*
- 4) *To set a process to be approved by MERC for stopping such complaints of installing series /check meters and including procedure of testing/checking meters.*
- 5) *Penalty to MSEDCL officers for non compliance of ombudsman's orders and wasting Valuable time of MERC.*
- 6) *Despite giving enough all supporting documents and evidences for tampering of series meter by MSEDCL staff, to justify the inaction of MSEDCL officials No action taken by MSEDCL higher-ups even after meeting with CMD of MSEDCL, CGRF Bhandup Zone, Hon. Ombudsman. This is nothing but they all have shielded concerned staff even after committing crime.*
- 7) *Delay if any, please be condemned is requested.*
