

**NOTICE**

Subject:- Petition filed by Serum Institute of India Private Limited for Purchase of banked wind units with MSEDCL, generated and injected by Serum Institute of India Private Limited (SIPL) in distribution system over and above open access wheeling, during the period April 2016 to March 2018 and MSEDCL denied the purchase of the same against SIPL's applications.

- **Case No. 49 of 2019**

Serum Institute of India Private Limited has filed a Petition on 20.02.2019 under Sections 42, 86 of the Electricity Act 2003 for Purchase of banked wind units with MSEDCL, generated and injected by Serum Institute of India Private Limited (SIPL) in distribution system over and above open access wheeling, during the period April 2016 to March 2018 and MSEDCL denied the purchase of the same against SIPL's applications.

The main prayers of the Petitioner are as under-

- 1) *Advise MSEDCL to purchase grid injected wind banked units @ 3,67,58,630 (April 2016 to March 2018) since they have accepted and recorded at their end and withdraw the denial letters related to the banked pending RE units with them.*
- 2) *Stop MSEDCL from use of resultant power flow formula for RE Consumer were TOD energy adjustment and banking of RE is permitted.*
- 3) *Since RE consumers are permitted for TOD adjustment and banking then stop MSEDCL from insisting separate standby SEM metering installation in addition to exiting main SEM metering in EHV substation for RE open access permission to EHV consumer , instead may insist for check meter as per metering regulations of CEA.*
- 4) *Direct respondent that grid injected RE units (1,98,32,155 and 1,69,26,475 ) by "Must run" Generator are additional to and carries cost and hence never get lapsed.*
- 5) *All other just and equitable reliefs are granted to the petitioner for the effective adjudication of this case.*

2. I am directed to communicate that the hearing in the above matter will be held on **Wednesday, 10 April, 2019 at 10.00 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Respondent before the scheduled date of hearing.

4. The Respondent is directed to submit the say on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition immediately, with a copy to the Petitioner.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
