Subject:- Petition of Classic Citi Investments Pvt. Ltd. for non compliance of the Hon'ble Commission's order dated 04.05.2018 in Case No. 36 of 2017 by Maharashtra State Electricity Distribution Company Ltd.

- **Case No. 51 of 2019**

Classic Citi Investments Pvt. Ltd. has filed Petition on 26.02.2019 under Section 142 read with section 146 and section 86(1) f of electricity act 2003 (with amendments in 2007) for non compliance of the Hon. Commission's order dated 04.05.2018 in Case No. 36 of 2017 by Maharashtra State Electricity Distribution Company Ltd.

The main prayers of the Petitioner are as under-

a. To direct the respondent to immediately release the STOA permissions for the balance quantity for the months of August, September 2016 and for entire 7.25 MW for May 2017 as directed by the Hon. Commission in their order dated 04th May 2017 in case No. 36 of 2017 and as per the DOAR 2016 read with the Practice Directions.

b. To initiate contempt proceedings for willful delay and denial of the orders of the Hon. Commission.

c. To permit the Petitioner to add/delete and or modify any of the points during the course of the hearing process.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
