Subject:- Petition filed by M/s. Gigaplex Estate Private Limited (GEPL) for approval of extension of Power Purchase Agreement (PPA) based on tariff determined through transparent process of bidding under Section 63 of the Electricity Act, 2003 and 'Guidelines for Short-term (i.e., for a period less than or equal to one year) Procurement of Power by Distribution Licensees through Tariff Based Bidding Process' issued by Ministry of Power, Government of India, on March 30, 2016, for procurement of power upto 2.5 MW (09:00-23:00 hours) (Weekdays, i.e. Monday to Friday and excluding Saturday, Sunday and national holidays) for a period of one year from 1st April, 2019 to 31st March, 2020.

- **Case No. 74 of 2019**

M/s. Gigaplex Estate Private Limited (GEPL) has filed a Petition on 15.03.2019 for approval of extension of Power Purchase Agreement (PPA) based on tariff determined through transparent process of bidding under Section 63 of the Electricity Act, 2003 and 'Guidelines for Short-term (i.e., for a period less than or equal to one year) Procurement of Power by Distribution Licensees through Tariff Based Bidding Process' issued by Ministry of Power, Government of India, on March 30, 2016, for procurement of power upto 2.5 MW (09:00-23:00 hours) (Weekdays, i.e. Monday to Friday and excluding Saturday, Sunday and national holidays) for a period of one year from 1st April, 2019 to 31st March, 2020.

The main prayers of the Petitioner are as under-

- i) *Request for hearing at the earliest date as the power flow is proposed to start on 1st April 2019.*
- ii) *approve the extension of PPA between GEPL and GMRETL, for procurement of power upto 2.5 MW (09:00-23:00 hours) (Weekdays, i.e. Monday to Friday and excluding Saturday, Sunday and national holidays) for a period of one year from 1st April, 2019 to 31st March, 2020 at the tariff of Rs. 4.36/kWh.*
- iii) *approve the PPA signed between GEPL and GMRETL under Section 86(1)(b) of the Electricity Act, 2003.*
- iv) *Condone any inadvertent omissions/errors/shortcomings and permit the Petitioner to add/change/modify/alter this filing and make further submissions as may be required at a further date.*
- v) *Pass such Orders as the Hon'ble Commission may deem fit in the facts of the present case.*

2. I am directed to communicate that the hearing in the above matter will be held on **Tuesday, 19 March, 2019 at 10 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) before the scheduled date of hearing.

4. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
