Maharashtra State Electricity Distribution Co. Ltd. has filed Petition on 05.03.2019 under Section 94 (1)(f) of the Electricity Act 2003 for review of Order dated 16.02.2018 in Case No. 44 of 2017 and Order dated 03.10.2018 in Case No. 111 of 2018 passed by the Hon'ble Commission.

The main prayers of the Petitioner are as under-

- b) *Hold and declare that the Respondent is not eligible for payment of any compensation for the months July, August and September, 2016 as the delay in those months are solely attributable to Respondent.*
- c) *Condone the delay in filing the Review Petition*
- d) *Pass such further orders as this Hon'ble Commission deems fit and proper in the interest of justice and good conscience.*
