- d) Direct MSEDCL to compensate the Petitioner for the unutilized banked energy to the tune of 2,40,904 units (upto 31st Dec, 2018) on account of non-adjustment of same because of illegal denial open access;
- e) Pass such further orders as this Hon'ble Commission deems fit and proper in the interest of justice and good conscience.
