Subject: Petition filed by Maharashtra State Power Generation Company Limited for review Order dated 5th February, 2019 passed by the Hon'ble MERC in Case No. 354 of 2018 on the Petition of Maharashtra State Power Generation Co. Ltd. for Removal of Difficulties by invoking Power to Relax Conditions for approval and adoption of Tariff and approval of PPA for Long Term Procurement of 50 MW Solar Power from Solar Power Plant at Kaudgaon under Section 63 and Section 86 (1) (b) of the Electricity Act 2003.

- **Case No. 75 of 2019**

The Petitioner Maharashtra State Power Generation Company Limited has filed on 15.03.2019 the Petition review Order dated 5th February, 2019 passed by the Hon'ble MERC in Case No. 354 of 2018 on the Petition of Maharashtra State Power Generation Co. Ltd. for Removal of Difficulties by invoking Power to Relax Conditions for approval and adoption of Tariff and approval of PPA for Long Term Procurement of 50 MW Solar Power from Solar Power Plant at Kaudgaon under Section 63 and Section 86 (1) (b) of the Electricity Act 2003.

- a) *The Hon'ble Commission may please admit the Review Petition;*
- b) *Grant an expeditious hearing of this Petition;*
- c) *Review the ruling in the order dated 05.02.2019 and approve the proposed tariff of Rs. 2.92 per unit for 25 years for the 50 MW solar PV project at Kaudgaon, Dist. Osmanabad;*
- d) *Approve the proposed Power Purchase Agreement and the proposed power procurement arrangement for Kaudgaon 50 MW Solar PV Project;*
- e) *Condone any shortcomings/deficiencies in the petition and allow MSPGCL to submit additional information/data at a later stage as may be required; and*
- f) *Pass such further order(s) as it deems just, fit and proper in the facts and circumstances of the case.*

6. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
