Subject: Petition filed by Maharashtra State Electricity Distribution Co. Ltd. against Global Energy Private Limited for non-compliance of Order dated 10.01.2019 in case no. 78 of 2018 passed by the Hon'ble Commission.

- **Case No. 62 of 2019**

The Petitioner Maharashtra State Electricity Distribution Co. Ltd. has filed on 08.03.2019 the Petition under Section 142, 146 & 149 of the Electricity Act 2003 against Global Energy Private Limited for non-compliance of Order dated 10.01.2019 in case no. 78 of 2018 passed by the Hon'ble Commission.

The main prayers of the Petitioner are as under-

- a) *Direct the Respondent to pay the outstanding amounts along with interest till date immediately as per the order dated 10.01.2019 passed by this Hon'ble Commission;*
- b) *Initiate appropriate action against the Respondent under Section 142, 146 and 149 of the Electricity Act, 2003;*
- c) *Pass such further orders as this Hon'ble Commission deems fit and proper in the interest of justice and good conscience.*
