- B. To consider the fuel oil / gas consumption required to run the Unit 5 at revised Technical minimum load at 55 % of installed capacity as "loss of operational parameters" while defining the compensation mechanism as per Section 8.2 of the MOD Guidelines.
- C. Pass such other order(s) as this Hon'ble Commission may deem fit and proper in the facts and circumstances of the case.
- D. Condone any inadvertent omissions/errors / rounding off differences / shortcomings and permit Tata Power-G to add / change / modify / alter this filing and make further submissions as may be required at a future date
