The main prayers of the Petitioner are as under-

- *i.* To Admit the Petition as per the Provisions of MERC Supply Code Regulation 2005 Section 5.5, Section 19.1 and Section 22 Section (24) are to be considered for further proceedings and to withdraw circular which violates Regulations and circular is invalid as per regulation provision and Hon'ble Commission to make order according to above provision.
 - *i.* Section 5.5 Violation of Regulation by MSEDCL
 - ii. Section 19.1- Invalid Circular
 - iii. Section 22.4 Commission to make order
 - iv. Hence respectfully pray Hon'ble Commission to withdraw MSEDCL circular No.30011 dtd.20/12/2018. please provide Relief by Stopping implementation and execution of circular till the final order of Hon'ble Commission. Till than procedure for New connection Applicant shall be prior to first January 20196 terms and conditions of supply of MSEDCL.
 - v. MSEDCL cannot modify or Amend terms and conditions of supply without prior Approval of Commission hence Relief to be granted.
- *ii.* In case Applicant opt to develop infrastructure network Reimbursement for RI charges, labour Charges, cost towards permissions to be reimbursed by MSEDCL including material cost.(but and only material cost)
- *iii.* Instead of Empanelment of Contractors by MSEDCL for infrastructure development, New connection Applicant is allowed to select Licensed Electrical Contractor of his choice.

- 1. These will distribute the electrical work among the Maximum number of contractors. Monopoly of Four to Five contracts to be eliminated.
- iv. Norms for Determination of Electrical load for Electrical load Residential/ Commercial/Industrial Complexes are to be division wise different subject to existing average consumption in that area.
 - *i.* Load Consumption Data avail with MSEDCL in all zones. Hence Mumbai area average consumption can't be compared with Nashik city area average consumption
- v. To Permit ECAM to make Further submissions, additions and alternation to this Petition as may be necessary from time to time.
- vi. To pass any order as the Hon'ble Commission may deem fit and appropriate under the circumstances of the case and on the interest of Justice.
- vii. To grant any other relief as the Hon'ble Commission may consider appropriate.
- viii. To condone any error/omission and to give opportunity to rectify the same.
