Subject: Petition filed by Powerica Limited seeking directions against Maharashtra State Electricity Transmission Company Limited for forfeiture of security deposit under various provisions of the Electricity Act, 2003 read with MERC (Transmission Open Access) Regulations, 2016

- **Case No. 81 of 2019**

The Petitioner Powerica Limited has filed on 22.03.2019 the Petition seeking directions against Maharashtra State Electricity Transmission Company Limited for forfeiture of security deposit under various provisions of the Electricity Act, 2003 read with Maharashtra Electricity Regulatory Commission (Transmission Open Access) Regulations, 2016

The main prayers of the Petitioner are as under-

- a) *Direct the Respondent to refund the amount of Rs. 1,00,00,000 (Rupees One Crore only) paid as Security Deposit towards the grid connectivity by the Petitioner or adjust the same against the proposed grid connectivity at 132/33kv Wadjire substation;*
- b) *Direct the Respondent to pay the costs for the present Petition; and*
- c) *To pass such further Order(s) as the Hon'ble Commission may deem fit and just in the facts and circumstances of the present case.*

2. I am directed to communicate that the hearing in the above matter will be held on **Thursday, 09 May, 2019 at 10.00 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

6. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
