Jagannath Narayan Appa has filed a Petition on 22.03.2019 Petition under Section 142 and 146 of the Electricity Act, 2003 against Maharashtra State Electricity Distribution Company Limited for non-Compliance of CGRF, Aurangabad Order dated 22.01.2019 passed in Case No. 706 of 2018

The main prayers of the Petitioner are as under-

1. *The petition may be admitted.*
2. *Respondent may be directed to comply Hon'ble CGRF, Aurangabad Order dated 22.01.2019 in case no. CGRF/AZ/AUR/JLN/706/2018/45.*
3. *The meter cost of Rs. 1200 should be refunded as old meter was tested and found untemper and seal was also OK.*
4. *Respondents may be penalized for Noncompliance of CGRF Order as per provision u/s 142 and 146 of Electricity Act 2003.*
5. *Respondents may be directed to pay compensation of Rs. 15000/- towards mental harassment and agony caused.*
6. *Respondents may be directed to pay Rs. 10000/- towards cost of filing this present petition.*
7. *Any other relief as deemed fit by Hon'ble Commission.*
