Subject:- Petition of Maharashtra State Electricity Distribution Company for seeking approval for adoption of Tariff for Long Term Procurement of 1000MW solar power under Section 63 of the Electricity Act, 2003 for meeting the solar Renewable Purchase Obligations.

- **Case No. 87 of 2019**

Maharashtra State Electricity Distribution Company Limited has filed Petition on 03.04.2019 Petition for seeking approval for adoption of Tariff for Long Term Procurement of 1000MW solar power under Section 63 of the Electricity Act, 2003 for meeting the solar Renewable Purchase Obligations.

The main prayers of the Petitioner are as under-

1. *To admit the Petition as per the provisions under Section 63 of the Electricity Act (EA), 2003.*
2. *To accord approval for adoption of tariff for 1000 MW solar power as stated in Para 3.9 discovered through Competitive bidding and the same to be made eligible for meeting the Solar RPO requirement of MSEDCL.*
3. *To accord approval for signing of PPA at discovered tariff.*
4. *To consider the submission made by the Petitioner and consider the same positively while deciding the Petition as well as for further actions;*
5. *To pass any other order/relief as the Hon'ble Commission may deem fit and appropriate under the circumstances of the case and in the interest of justice;*
6. *To condone any error/omission and to give opportunity to rectify the same;*
7. *To permit the Petitioner to make further submissions, addition and alteration to this Petition as may be necessary from time to time.*
