Subject:- Petition of Maharashtra State Electricity Distribution Company Limited for seeking approval for procurement of bagasse based co-generation power under Section 62 and 86 (1) (b), (e) of the Electricity Act, 2003 for meeting the non-solar Renewable Purchase Obligation.

- **Case No. 88 of 2019**

Maharashtra State Electricity Distribution Company Limited Global Energy Private Limited has filed Petition on 15.03.2019 Petition for seeking approval for procurement of bagasse based co-generation power under Section 62 and 86 (1) (b), (e) of the Electricity Act, 2003 for meeting the non-solar Renewable Purchase Obligation.

The main prayers of the Petitioner are as under-

1. *To admit the Petition as per the provisions of Section 62 and 86 (1) (b), (e) of the Electricity Act 2003.*
2. *To accord approval to the rate of APPC (excluding Renewable Energy and transmission charges) for long term procurement of power from FY 2019-20 till the remaining useful life of the project in respect of all bagasse based co-generation plant those will complete EPA period of 13 years.*
3. *To accord approval that the energy purchased by MSEDCL from such projects is entitled for fulfillment of non solar RPO target of MSEDCL*
4. *To consider the submission made by the Petitioner and consider the same positively while deciding the Petition as well as for further actions;*
5. *To pass any other order/relief as the Hon'ble Commission may deem fit and appropriate under the circumstances of the case and in the interest of justice;*
6. *Condone any error/omission and to give opportunity to rectify the same;*
7. *To permit the Petitioner to make further submissions, addition and alteration to this Petition as may be necessary from time to time*

3. I am directed to communicate that the hearing in the above matter will be held on **Monday, 20 May, 2019 at 10.00 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.
