Shri Shankarsa Vishwanath Wade through of Shri Aditya Rajendra Wade has filed Petition on 30.04.2019 Petition under Section 142, 146 and 149 of Electricity Act, 2003 for Non-Compliance of CGRF Nashik Order dated 15.02.2019.

- ४) महावितरणाने हेतुःपुरसर मला त्रास देण्याच्या उद्देशाने व माझ्याकडून अतिरिक्त रक्कम वसूल करण्याच्या हेतूने विद्युत पुरवठा जोडत नसल्याने , मला झालेल्या त्रासापोटी तसेच मा. न्यायमंचातील तक्रारीचा व प्रवासाचा आणि झालेल्या मानसिक,शारीरिक व आर्थिक त्रासापोटी एकत्रित रक्कम रुपये ४००००/- मला नुकसान भरपाई देण्यासाठी महावितरणाला आदेशित करावे.
