Subject:- Petition for seeking approval on adoption of tariff for long term procurement of bagasse based co-generation power for meeting the non-solar renewable purchase obligations under Section 63 of the Electricity Act, 2003.

Case No. 109 of 2019

Maharashtra State Electricity Distribution Co. Ltd. has filed on 07.05.2019 the Petition for seeking approval on adoption of tariff for long term procurement of bagasse based co-generation power for meeting the non-solar renewable purchase obligations under Section 63 of the Electricity Act, 2003.

The main prayers of the Petitioner are as under-

- 1) *To admit the Petition as per the provisions of Section 63 of the Electricity Act 2003.*
- 2) *To accord approval for adoption of tariff as discovered in the competitive bidding process.*
- 3) *To accord approval for purchase of power for capacity of 109 (12+97) MW from the successful bidder for a period of 20 years from Commercial Operation Date (COD) at a tariff of Rs. 4.75 per unit.*
- 4) *To consider the purchase of power for meeting the Non-solar RPO requirement of MSEDCL*
- 5) *To consider the submission made by the Petitioner and consider the same positively while deciding the Petition as well as for further actions;*
- 6) *To pass any other order/relief as the Hon'ble Commission may deem fit and appropriate under the circumstances of the case and in the interest of justice;*
- 7) *Condone any error/omission and to give opportunity to rectify the same;*
- 8) *To permit the Petitioner to make further submissions, addition and alteration to this Petition as may be necessary from time to time.*
