Subject:- Petition seeking approval for deviation in Standard Bidding Document for Long Term Procurement of 500 MW wind power from the Wind Generators whose Energy Purchase Agreement with Maharashtra State Electricity Distribution Co. Ltd are expired / going to expire in FY 2019-20, for meeting non-solar RPO target.
Case No. 110 of 2019

1. Maharashtra State Electricity Distribution Co. Ltd. has filed on 07.05.2019 the Petition seeking approval for deviation in Standard Bidding Document for Long Term Procurement of 500 MW wind power from the Wind Generators whose EPA with MSEDCL are expired / going to expire in FY 2019-20, for meeting non-solar RPO target.

The main prayers of the Petitioner are as under-

1. *To admit the Petition as per the provisions of the Regulation 19 of MERC (RPO, Its Compliance and Implementation of REC Framework) Regulations, 2016.*
2. *To accord approval for the proposed deviations as mentioned in paragraph 11 of this Petition from the Standard Bidding Guidelines issued by the Ministry of Power dated 3rd August 2017 and its amendments thereof and allow to incorporate these deviations in the bid documents (RfS and PPA).*
3. *To allow MSEDCL to claim such procurement for the fulfilment of RPO of MSEDCL*
4. *To consider the submission made by the Petitioner and consider the same positively while deciding the Petition as well as for further actions;*
5. *To pass any other order/relief as the Hon'ble Commission may deem fit and appropriate under the circumstances of the case and in the interest of justice;*
6. *Condone any error/omission and to give opportunity to rectify the same;*
7. *To permit the Petitioner to make further submissions, addition and alteration to this Petition as may be necessary from time to time.*

4. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the impleaded Respondent before the scheduled date of hearing.

5. The impleaded Respondent is directed to submit the say on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition immediately, with a copy to the Petitioner.
6. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
