- c) *For Payment of excess amount billed along with interest immediately to the Applicant as per Order of CGRF.*
- d) *For compensation of Rs.2,50,000/- towards harassment and no compliance of order to the Applicant*
- e) *For Legal cost of Rs.2,50,000/- to the Applicant.*
