The main prayers of the Petitioner are as under-

- a) Declare imposition of Safeguard Duty by the Ministry of Finance vide its notification dated 30.07.2018 as a Change in Law event under Article 9.1 of the PPA with effect from 30.07.2018;
- b) Declare that the Petitioner is entitled to claim relief under Article 9.2 of the PPA for the additional expenditure incurred on account of the Change in Law Event, i.e. imposition of Safeguard Duty by the Ministry of Finance vide its notification dated 30.07.2018 with effect from 30.07.2018 along with GST thereon;
- c) Specify the mechanism for deciding the quantum of relief that the Petitoner is entitled to on account of the aforesaid Change in Law event under Article 9.2 of the PPA along with applicable interest from date of incurrence of Safeguard Duty;
- d) Direct the Respondent to pay the quantum of compensation as per said mechanism to the Petitoner on account of the aforesaid Change in Law event subsequent to specifying the mechanism under Article 9.2 of the PPA;
- e) Direct the Respondent to reimburse the legal and administrative costs incurred by the Petitioner in pursuing the instant Petition; and
- f) Pass such other orders that this Hon'ble Commission deems fit in the facts of this case.
