

**NOTICE**

Subject:- Petition filed by M/s Relishah Export for Non Compliance of the Order dated 28.09.2018 in Case No. 134 of 2018 passed by the Commission directing the respondent to make the payment of delayed payment charges (DPC).

- **Case No. 127 of 2019**

M/s Relishah Export has filed a Petition on 30.05.2019 under Sections 142,146 and 149 of the Electricity Act, 2003 for Non Compliance of the Order dated 28.09.2018 in Case No. 134 of 2018 passed by the Commission directing the respondent to make the payment of delayed payment charges (DPC).

The main prayers of the Petitioner are as under-

- a) *To initiate the contempt proceedings against Respondent for the non- compliance of Hon'ble Commission's directives.*
- b) *Direct the Respondent to comply with the directions given by the Hon'ble Commission in the order dated 28.09.2018 and pay immediately the Delayed Payment Charge (DPC) amounting Rs. 26,67,977/- (Rupees Twenty Six Lakh Sixty Seven Thousand Nine Hundred Seventy Seven only) as per the reconciled statement dated 30.06.2018 and 09.10.2018.*
- c) *Direct the Respondent to pay the DPC amount for payments of the invoices from October 2017 to June 2018 made on 17.11.2018 and 25.12.2018 amounting Rs. 1,16,051/- (Rupees One Lakh Sixteen Thousand Fifty One only).*
- d) *Direct the Respondent to pay interest on DPC amount referring point (b) and (c) of the above prayer as directed by the Hon'ble Commission in the order dated 28.09.2018.*
- e) *Direct the Respondent to continue to make timely payment for the future invoices as per the terms of WEPA;*
- f) *Call for the entire record relating to the case of Petitioner and after perusing the same, pass such appropriate order or direction;*
- g) *Pass, any other appropriate relief, order or direction, which this Hon'ble Commission deems just and proper in the facts and circumstances of the present case, in favour of Petitioner.*

2. I am directed to communicate that the hearing in the above matter will be held on **Wednesday, 26 June, 2019 at 10.00 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
