

**NOTICE**

Subject:- Petition of Maharashtra State Power Generation Company Limited for seeking approval for deviation in bidding document from MOP guidelines for Long Term Procurement of Solar Power under “Mukhyamantri Saur Krishi Vaahini Yojana” with 2 to 10 MW capacity projects connected to distribution network with total quantum of 184 MW (50 MW each for western Maharashtra, Northern Maharashtra and Marathwada region and 34 MW for Vidarbha Region) through competitive bidding (E- Reverse Auction).

- **Case No. 141 of 2019**

The Petitioner Maharashtra State Power Generation Company Limited has filed the Petition on 11.06.2019 under Section 63 of the Electricity Act,2003 for seeking approval for deviation in bidding document from MOP guidelines for Long Term Procurement of Solar Power under “Mukhyamantri Saur Krishi Vaahini Yojana” with 2 to 10 MW capacity projects connected to distribution network with total quantum of 184 MW (50 MW each for western Maharashtra, Northern Maharashtra and Marathwada region and 34 MW for Vidarbha Region) through competitive bidding (E- Reverse Auction).

The main prayers of the Petitioners are as under-

- a) *To accord approval for deviation in competitive bidding for capacity less than 5MW in standard bidding guidelines for purchase of 184 MW of Solar PV power under ‘Mukhyamantri Saur Krishi Vaahini Yojana’;*
- b) *To accord approval to the proposed changes in clause for “Generation Compensation in off-take constraint due to transmission/Distribution network”;*
- c) *To approve the proposed PBG clause as it is based on practical observations and is in favor of the scheme being implemented.*
- d) *To accord approval for factoring reduction in land cost, so that MSPGCL can put the ceiling tariff of Rs.3.23 per unit;*
- e) *To consider the submission made by the Petitioner and consider the same positively while deciding the Petition as well as for further actions;*
- f) *To pass any other order/relief as the Hon’ble Commission may deem fit and appropriate under the circumstances of the case and in the interest of justice;*
- g) *To condone any error/omission and to give opportunity to rectify the same;*

*h) To permit the Petitioner to make further submissions, addition and alteration to this Petition as may be necessary from time to time.*

2. I am directed to communicate that the hearing in the above matter will be held on **Friday, 05 July, 2019 at 10.00 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) before the scheduled date of hearing.

4. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
