**a**. Quash the email dated May 3, 2019 sent by MSEDCL to Petitioner denying grant of MTOA permission for self-use for its Unit and direct Respondent to grant MTOA permission to the tune of 2.4 MW for Unit sought vide application with ID. 8368 w.e.f. April 1, 2019 to March 31, 2022;

**b.** Direct Respondent to give credit notes for power generated which is not adjusted in the bills of the Petitioner for the power injected in the grid from April 1, 2019;

C. Direct Respondent to permit adjustment of credit notes issued in terms of prayer (b) above in the bills of the Petitioner not limited to the FY 2019-20 as adjustment may not happen due to unjustified denial of MTOA by MSEDCL;

**d.** Direct Respondent to adhere to DOA Regulations and Practice Directions whilst processing open access permissions in letter and spirit;

*e.* Direct Respondent to continue granting open access permissions to the Petitioner in accordance with applicable laws;

*f.* Award costs of this proceedings against the Respondent and in favour of the Petitioner; and

**g.** Pass such other orders as this Hon'ble Commission may deem just in the facts of the present case.
