The main prayers of the Petitioner are as under-

- (a) Hold and direct MSEDCL to forthwith grant open access with effect from 1st May 2019 to the Petitioner pending the installation of SEMs by MSEDCL at the wind turbine of the Petitioner;
- (b) Direct MSEDCL to install the SEMs at the generating station of the Petitioner forthwith;
- (c) Hold and direct MSEDCL to give credit for the electricity injected by the Petitioner to its captive consumption from 01/05/2019;
- (d) Hold and direct that MSEDCL to pay a principal amount of Rs. 791.72 lakh as compensation for the loss caused on account of the illegal and wrongful denial of open access for the period up to 30th April 2022,
- (e) Hold and direct MSEDCL to compensate the Petitioner for any further losses caused beyond 31/05/2019 due to the wrongful denial of open access on account of non-availability of SEMs at the wind turbine generator;
- (f) Award interest on the compensation payable in terms of prayer (b) and (c) above at the rate of 18% per annum payable till the date the compensation is paid by MSEDCL to the Petitioner;
- (g) Initiate penal action against MSEDCL under Section 142 for violation of the provisions of the DOA Regulations and also the directions of the Hon'ble Commission in Case No. 34 of 2019;
