

**NOTICE**

Subject: - Appeal filed by Maharashtra State Electricity Company Ltd. formerly known as MSEB against Electrical Inspector (EI) Thane, Order dated 2.6.2003 all bills issued since January, 1999 to January, 2002 were quashed and directed to issue revised bills (meter showing zero consumption) average bill issue.

- **Case No. 149 of 2019**

1) The Government of Maharashtra, as per Section 162 (2) of The Electricity Act, 2003 has directed the Commission to entertain, conduct the hearing & decide the appeal filed against the decision of Chief Electrical Inspector or Electrical Inspector and has issued notification on 01 January, 2019 to that effect as under:-

*“-..... Where as under Sub-section (2) of section 162 of the Electricity Act, 2003; and Sub-section (2) of Section 36 of the repealed Indian Electricity Act, 1910, the powers of Appellate Authority are vested with the Government of Maharashtra.*

*Now, in exercise of powers under Sub-section (2) of Section 162 of the Electricity Act, 2003, it is hereby directed to the Maharashtra Electricity Regulatory Commission to entertain, conduct the hearing and decide the Appeal filed against the decision of the Chief Electrical Inspector or an Electrical Inspector as per provision under section 36 (2) of Indian Electricity Act, 1910. ”*

2) I am directed to communicate that; the Commission has impleaded 1) Chief Electrical Inspector 2) Through the Secretary, Industries, Energy and Labour Department, Government of Maharashtra as Parties.

3) I am directed to communicate that, the hearing in the matter will be held on **Wednesday, 24 July 2019 at 10.00** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

4) The Petitioner/Applicant/ Appellant is directed to immediately serve a copy of its above-mentioned Petition/Application/Appeal (both in soft and hard Copy) to the Respondents/impleaded Parties atleast 15 days before the scheduled date of hearing.

5) The Respondents/ impleaded Parties are directed to submit the say on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition immediately, with a copy to the Petitioner atleast 8 days before the date of hearing.

6) The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
