Subject:- Petition filed by M/s Jindal Polyfilms Ltd seeking punishment for the Non Compliance of the Open Access Regulations and practice directions issued dated 08.03.2017 issued by the Maharashtra Electricity Regulations by the MSEDCL.

- **Case No. 153 of 2019**

M/s Jindal Polyfilms Ltd. has filed a Petition on 21.06.2019 Petition seeking punishment for the Non Compliance of the Open Access Regulations and practice directions issued dated 08.03.2017 issued by the Maharashtra Electricity Regulations by the MSEDCL.

1. The main prayers of the Petitioner are as under-

A) *The Hon'ble Commission may punish the respondents MSEDCL for noncompliance of the Provisions of the Electricity, Act, Open Access Regulations and the Practice direction of the MERC, U/sec. 142, 146 & 149 of the Electricity Act, 2003.*

B) *The Hon'ble Commission may declare that, the action of the MSEDCL in recovering the excessive transmission charges and retaining the same in violation with Open access Regulations, practice direction of MSERC is illegal.*

C) *The Hon'ble Commission may be pleased to direct the MSEDCL to refund the amount of Rs.27,87,044/- to the petitioner as per the regulations and practice regulations along with interest.*

D) *Any other relief in the interest of justice.*

4. The Respondents are directed to submit the say on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition immediately, with a copy to the Petitioner.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
