

**NOTICE**

Subject:- Petition of Mrs. Aishwarya Rai Bachchan for non compliance of the Order dated 04.01.2019 in Case No. 256 of 2018 passed by this Hon'ble Commission directing the Respondent to make the payment of delayed payment charges (DPC).

- **Case No. 157 of 2019**

The Petitioner Mrs. Aishwarya Rai Bachchan has filed the Petition on 26.06.2019 under Sections 142,146 and 149 of the Electricity Act, 2003 for non compliance of the Order dated 04.01.2019 in Case No. 256 of 2018 passed by this Hon'ble Commission directing the Respondent to make the payment of delayed payment charges (DPC).

The main prayers of the Petitioners are as under-

a) *To initiate the contempt proceedings against Respondent for the non- compliance of Hon'ble Commission's directives.*

b) *Direct the Respondent to comply with the directions given by the Hon'ble Commission in the order dated 04.01.2019 and pay immediately the Delayed Payment Charge (DPC) amounting Rs. 82,48,679/- (Rupees Eighty Two Lakh Forty Eight Thousand Six Hundred Seventy Nine only) as per the reconciled statement dated 22.01.2019.*

c) *Direct the Respondent to pay the DPC amounts: (i) For Dhule project (WTG location K485 and K487), for the payment made on 30.03.2019 for the invoices from November 2017 to August 2018, and for the payment made on 03.04.2019 for the invoice of September 2018; (ii) For Sinner project (WTG location AD29), for the payment made on 30.03.2019 for the invoices from October 2017 to August 2018, and for the payment made on 03.04.2019 for the invoice of September 2018.*

d) *Direct the Respondent to pay interest on DPC amount referring point (b) and (c) of the above prayer as directed by the Hon'ble Commission in the order dated 04.01.2019.*

e) *Direct the Respondent to pay the outstanding principal invoices as per the reconciled statement dated 22.01.2019.*

f) *Direct the Respondent to continue to make timely payment for the future invoices as per the terms of WEPAs;*

*g) Call for the entire record relating to the case of Petitioner and after perusing the same, pass such appropriate order or direction;*

*h) Pass, any other appropriate relief, order or direction, which this Hon'ble Commission deems just and proper in the facts and circumstances of the present case, in favour of Petitioner.*

2. I am directed to communicate that the hearing in the above matter will be held on **Monday, 19 August, 2019 at 10.00 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Respondent before the scheduled date of hearing.

4. The Respondent is directed to submit the say on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition immediately, with a copy to the Petitioner.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
