The Petitioner Sri Amareshwara Industries has filed the Petition on 08.07.2019 under Section 142 & 146 of Electricity Act, 2003 for wrongful cancellation of STOA permission.

The main prayers of the Petitioners are as under-

- a) *That letter sent by Respondent No.2 bearing No. SE/VC/HTB/007250 dated 30-10-2018 be declared as null and void.*
- b) *That Respondent No.2 be directed to rectify the energy bill of Respondent No.3 for the month of April 2018 and issue O.A. bill giving due credit for Open Access units.*
- c) *That Respondent No.1 & 2 be directed to pay an amount which this Hon'ble Commission thinks just and proper as compensation against the deficient service rendered by the Respondents.*
- d) *All other just and equitable reliefs be granted in favour of the petitioners for the effective adjudication of this case.*
