Subject:- Petition of Mr. Dhananjay Hari Gadgil under Section 13 and 14 of Hon'ble MERC (Net Metering for Roof-top Solar Photo Voltaic Systems) Regulations, 2015 for adjustment of excess injected units from installed Roof-top Solar PV system to the Petitioners another LT Residential connection.

- **Case No. 163 of 2019**

The Petitioner Mr. Dhananjay Hari Gadgil has filed the Petition on 17.07.2019 under Section 13 and 14 of Hon'ble MERC (Net Metering for Roof-top Solar Photo Voltaic Systems) Regulations, 2015 for adjustment of excess injected units from installed Roof-top Solar PV system to the Petitioners another LT Residential connection.

1. The main prayers of the Petitioner are as under-

- i) *It is prayed that an amendment in Hon'ble Maharashtra Electricity Regulatory Commission (Net Metering for Roof-top Solar Photo Voltaic Systems) Regulations, 2015 may be given limited to adjustment of excess units Overinjected from Roof-top Solar Photo Voltaic Systems of one connection to another connection owned by same consumer.*
- ii) *It is prayed that the Respondent may be directed to give the credit adjustment of balance excess units Overinjected from Petitioner's 10KW Roof-top Solar Photo Voltaic Systems of Consumer No. 279940213732 to Petitioner's another LT Residential Connections bearing Consumer No. 279941310006 and having Sanctioned Load 8.1 KW at Ganraj Prasad Apartment, Flat No. F-1, Rajwada Chowk, Khanbag, Sangli-416416.*
- iii) *It is prayed that the Respondent may be directed to revised the electricity bills of Consumer No. 279941310006 and having Sanctioned Load 8.1 KW at Ganraj Prasad Apartment, Flat No. F-1, Rajwada Chowk, Khanbag, Sangli-416416 accordingly.*
- iv) *Pass such other orders as this Hon'ble Commission may deem just in the facts of the present case.*
