Subject:- Petition of Maharashtra State Electricity Distribution Company in review petition in respect of MERC's order in Case No. 64 of 2019, MSEDCL seeking approval for adoption of tariff discovered for Long term procurement of 1170 MW solar power under 'Mukhyamantri saur Krishi Vahini Yojana' for meeting the solar Renewable Purchase Obligation under section 63 & 94 (1) (f) of the electricity act, 2003.

- **Case No. 168 of 2019**

Maharashtra State Electricity Distribution Company Limited has filed Petition on 23.07.2019 review petition in respect of MERC's order in Case No. 64 of 2019, MSEDCL seeking approval for adoption of tariff discovered for Long term procurement of 1170 MW solar power under 'Mukhyamantri saur Krishi Vahini Yojana' for meeting the solar Renewable Purchase Obligation under section 63 & 94 (1) (f) of the electricity act, 2003.

The main prayers of the Petitioner are as under-

- a) *To admit the Petition as per the Sections 63 & 94 (1)(f) of The Electricity Act, 2003.*

- c) *To adopt the tariffs discovered through competitive bidding in respect of 1160 MW capacity of solar power projects as stated in para 5 of this petition.*
- d) *Condone any error/omission and to give opportunity to rectify the same.*
- e) *To permit the Petitioner to make further submissions, addition and alteration to this Petition as may be necessary from time to time.*
