Subject:- Petition of Maharashtra Airport Development Company for approval and direction under section 86 of the Electricity Act, 2003 read with 'Guidelines for short term (i.e. for a period of more than one day to one year) Procurement of power by Distribution Licensees' dated 30th March 2016 issued by the Ministry of Power, Government of India.

- **Case No. 165 of 2019**

The Petitioner Maharashtra Airport Development Company has filed the Petition on 19.07.2019 for approval and direction under section 86 of the Electricity Act, 2003 read with 'Guidelines for short term (i.e. for a period of more than one day to one year) Procurement of power by Distribution Licensees' dated 30th March 2016 issued by the Ministry of Power, Government of India.

1. The main prayers of the Petitioner are as under-

(i) *a Admit the present petition;*

(ii) *Approve the plan for short term procurement of power in its capacity as a Distribution Licensee as per the 'Guidelines for short term (i.e. for a period of more than one day to one year) procurement of power by Distribution Licensees through Tariff based bidding process' dated 30th March 2016 issued by the Ministry of Power for the period of one year starting from 01.09.2019 to 31.08.2020;*

(iii) *Allow the deviation sought as per Clause No. 8 of the 'Guidelines for short term (i.e. for a period of more than one day to one year) procurement of power by Distribution Licensees through Tariff based bidding process' dated 30th March 2016 issued by the Ministry of Power'*

(iv) *Allow MADC to charge consumers in the MIHAN SEZ area, the tariff that is applicable for the respective category of consumers in the MSEDCL area of supply, as modified from time to time, as the 'maximum ceiling tariff' in its area of supply, till such time the ARR and the tariff is determined by this Hon'ble Commission, and approve the appropriate tariff schedule as applicable in the MSEDCL area of supply;*

(v) *In case the requirement of power in the MIHAN SEZ increases from 16 MW, then in that case MADC be allowed to procure the same through IEX.*

(vi) *Direct MSETCL for extending its co-operation and support to MADC in supplying power to consumers in MIHAN SEZ.*

(vii) *Pass any other other/further order(s) as this Hon'ble Commission may deem fit in the interest of justice;*

(viii) *Condone any error/omission and to grant an opportunity to the Petitioner to rectify the same;*

(ix) *Permit the Petitioner to make such further submission(s), addition(s) and alteration(s) to this Petition as may be necessary from time to time.*

2. I am directed to communicate that the hearing in the above matter will be held on **Thursday, 08 August, 2019 at 10.00 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Respondents before the scheduled date of hearing.

4. The Respondents are directed to submit the say on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition immediately, with a copy to the Petitioner.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
