

NOTICE

Subject:- Petition of Bajaj Finserv Limited under Regulation 19 of MERC (Forecasting, Scheduling and Deviation Settlement for Solar and Wind Generation) Regulation, 2018 for removal of difficulties in giving effect to the provision of the Regulation and implementation thereof.

- **Case No. 172 of 2019**

The Petitioner Bajaj Finserv Limited has filed the Petition on 25.07.2019 under Regulation 19 of MERC (Forecasting, Scheduling and Deviation Settlement for Solar and Wind Generation) Regulation, 2018 for removal of difficulties in giving effect to the provision of the Regulation and implementation thereof.

The main prayers of the Petitioner are as under-

- i. a Admit the petition for removing practical difficulties faced by the Petitioner at pooling substation Vankuswade Dist: Satara and MalharpethDist: Satara, in implementation of MERC (Forecasting, Scheduling and Deviation Settlement for Solar and Wind Generation) Regulations, 2018 as provided under the provisions of regulation 19 of the said Forecasting Regulation 2018.*
- ii. During the pendency of this Petition and till such time practical difficulties faced by the Petitioner at pooling substation VankuswadeDist: Satara and MalharpethDist: Satara, in implementation of MERC (Forecasting, Scheduling and Deviation Settlement for Solar and Wind Generation) Regulations, 2018 is not removed, no penalty may be imposed on the Petitioner for any violation of the said Forecasting Regulation, 2018*
- iii. Issue necessary clarification and direction/instruction to MSLDC to remove discrepancy in connected windmill capacity mentioned in approval letter of Respondent No. 2 as QCA for 220 kV Vankuswade S/S issued by MSLDC.*
- iv. Provide necessary clarification and issue necessary direction/instruction relating to appointment of QCA for Malharpeth PSS where currently no entity is in a position to achieve specified 51% majority i.e. the eligibility criteria prescribed under the provisions of Forecasting Regulation 2018 for appointment as QCA.*
- v. Issue necessary clarification and direction/instruction to MSLDC to remove practical difficulties at Malharpeth PSS for appointment of QCA and till such time QCA is not appointed, not to levy DSM penalty on Petitioner's wind generation unit connected at said PSS.*
- vi. Provide such other relief/reliefs which the Petitioner may be entitled to in facts and circumstances of this case to for removing practical difficulties faced by the Petitioner in implementation of MERC (Forecasting, Scheduling and Deviation Settlement for Solar and Wind Generation) Regulations, 2018.*

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Respondents before the scheduled date of hearing.
4. The Respondents are directed to submit the say on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition immediately, with a copy to the Petitioner.
5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
