- **4.** Provide such other relief/reliefs which the Petitioner may be entitled to in facts and circumstances of this case to for removing practical difficulties faced by the Petitioner in implementation of MERC (Forecasting, Scheduling and Deviation Settlement for Solar and Wind Generation) Regulations, 2018
