- **3.** Provide necessary clarification and issue necessary direction/instruction relating to appointment of QCA for Malharpeth PSS where currently no entity is in a position to achieve specified 51% majority i.e. the eligibility criteria prescribed under the provision of Forecasting Regulation 2018 for appointment as QCA.
- **4.** Issue necessary clarification and direction/instruction to MSLDC to remove practical difficulties at Malharpeth PSS for appointment of QCA and till such time QCA is not appointed, not to levy DSM penalty on Petitioner's wind generation unit connected at said PSS.
- 5. Provide such other relief/reliefs which the Petitioner may be entitled to in facts and circumstances of this case to for removing practical difficulties faced by the Petitioner in implementation of MERC (Forecasting, Scheduling and Deviation Settlement for Solar and Wind Generation) Regulations, 2018
