

NOTICE

Subject:- Petition of Sridevi Trading Company (Satara) under Regulation 19 of MERC (Forecasting, Scheduling and Deviation Settlement for Solar and Wind Generation) Regulation, 2018 for removal of difficulties in giving effect to the provision of the Regulation and implementation thereof.

- **Case No. 224 of 2019**

The Petitioner Sridevi Trading Company (Satara) has filed the Petition on 07.08.2019 under Regulation 19 of MERC (Forecasting, Scheduling and Deviation Settlement for Solar and Wind Generation) Regulation, 2018 for removal of difficulties in giving effect to the provision of the Regulation and implementation thereof.

The main prayers of the Petitioner are as under-

1. *Admit the petition for removing practical difficulties faced by the Petitioner in implementation of MERC (Forecasting, Scheduling and Deviation Settlement for Solar and Wind Generation) Regulations, 2018 as provided under the provisions of regulation 19 of the said Forecasting Regulation 2018.*
2. *Provide a trial/grace period of 6 months w.e.f. 01st July 2019 to assess the challenges faced in compliance with the provisions of Forecasting Regulation 2018 relating to scheduling and forecasting and penalty be levied for any deviation thereafter instead of penalty being imposed for any deviation from the date of coming effect of said Forecasting Regulation 2018 i.e. 01st July 2019.*
3. *Issue necessary clarification and direction/instruction to MSLDC to remove discrepancy in connected windmill capacity mentioned in approval letter of Respondent No.2 as QCA for 220 Kv Vankuswade S/S issued by MSLDC.*
4. *Provide such other relief/reliefs which the Petitioner may be entitled to in facts and circumstances of this case to for removing practical difficulties faced by the Petitioner in implementation of MERC (Forecasting, Scheduling and Deviation Settlement for Solar and Wind Generation) Regulations, 2018*

2. I am directed to communicate that the hearing in the above matter will be held on **Thursday, 22 August, 2019 at 10.00 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
