

NOTICE

Subject:- Petition of S. R. Thorat Milk Products Private Limited for adjudication of dispute between a Renewable Energy Generator and Distribution Licensee.

- **Case No. 199 of 2019**

The Petitioner S. R. Thorat Milk Products Private Limited filed this Petition on 06.08.2019 under Section 42(2), 86(1) (f), 60 and 66 the Electricity Act, 2003 read with regulation 32 of the MERC (Distribution Open Access) Regulation, 2016 for adjudication of dispute between a Renewable Energy Generator and Distribution Licensee.

The main prayers of the Petitioner are as under-

- a) *Direct MSEDCL to issue "Generation Credit Notes" forthwith, for the power supplied under open access by the Petitioner since January, 2019 till date;*
- b) *In the alternative, hold and declare that the amount of losses, if any, which would be caused to the Petitioner, on account of non-claiming of REC's as per the timelines prescribed under the CERC (REC Procedure) dated 05.11.2015, because of delay in issuance of "Generation Credit Notes", shall be borne entire by MSEDCL and be compensated by MSEDCL to the Petitioner accordingly;*
- c) *Direct MSEDCL to issues "Generation Credit Notes" on a month to month basis, on power injected under valid open access permissions;*
- d) *Pass such further orders as this Hon'ble Commission deems fit and proper in the interest of justice and good conscience.*

2. I am directed to communicate that the hearing in the above matter will be held on **Thursday, 17 September, 2019 at 10.00 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Respondent before the scheduled date of hearing.

4. The Respondent is directed to submit the say on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition immediately, with a copy to the Petitioner.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
