Subject:- Petition of Mrs. Geetha Pundaleeka against Maharashtra State Electricity Distribution Company Limited for non-compliance of common Order dated 09.10.2019 in Case No. 262 of 2018.  
- **Case No. 197 of 2019**

The Petitioner Mrs. Geetha Pundaleeka filed this Petition on 06.08.2019 under Section 142, 146 & 149 of the Electricity Act, 2003 against Maharashtra State Electricity Distribution Company Limited for non-compliance of common Order dated 09.10.2019 in Case No. 262 of 2018.

The main prayers of the Petitioner are as under-

- a) *Direct the Respondent to pay the principal outstanding amounts alongwith applicable DPC and interest (as reflected at Annexure- B) till date, immediately, as per the Common Order dated 09.01.2019 passed by this Hon'ble Commission in Case No. 262 of 2018;*
- b) *Initiate appropriate action against the Respondent under Section 142, 146 and 149 of the Electricity Act, 2003 for deliberate and willful non-compliance of Common Order dated 09.01.2019 passed by this Hon'ble Commission in Case No. 262 of 2018*
- c) *Pass such further orders as this Hon'ble Commission deems fit and proper in the interest of justice and good conscience.*

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
