- **3.** Issue necessary clarification and direction/instruction to MSLDC to remove discrepancy in connected windmill capacity mentioned in approval letter of Respondent No. 2 as QCA for 220 Kv Vankuswade S/S issued by MSLDC.
- **4.** Provide such other relief/reliefs which the Petitioner may be entitled to in facts and circumstances of this case to for removing practical difficulties faced by the Petitioner in implementation of MERC (Forecasting, Scheduling and Deviation Settlement for Solar and Wind Generation) Regulations, 2018.
