

**NOTICE**

Subject:- Petition of Panexcell Clinical Lab Private Limited for noncompliance Order of Hon'ble CGRF dated 06.03.2019 as per Regulation 22 of MERC (Consumer Grievance Redressal Forum and Electricity Ombudsman) Regulation, 2006.  
- **Case No. 239 of 2019**

The Petitioner Panexcell Clinical Lab Private Limited has filed this Petition on 21.08.2019 under Section 142 & 146 of Electricity Act, 2003 for noncompliance Order of Hon'ble CGRF dated 06.03.2019 as per Regulation 22 of MERC (Consumer Grievance Redressal Forum and Electricity Ombudsman) Regulation, 2006.

The main prayers of the Petitioner are as under-

- a) *We request Hon'ble Commission to compensate the (Division Officer) Vashi Navi Mumbai, who has given the threat that, he has gone to Hon'ble High Court. We have to pay the wrong bills with interest also the said fake assessment is yet not removed through our energy bill.*
- b) *We also request Hon'ble Commission to give directive to concern officer i.e Superintending Engineer Vashi to comply CGRF Order or register our case as per provision of law u/s/142 & 146 E.A.2003 for noncompliance of Hon'ble C.G.R.F. order.*
- c) *It is also prayed that the compensation to the applicant be allowed for the harassment and compelling the applicant to carry out the work on his own by shirking away the direction of the Hon'ble CGRF order.*
