- b. That the Hon'ble Commission declare and held that the Force majeure has crept for the period between 2010 to 2015 and thus, the project of the Petitioner was established in time as per the EPA entered between the parties;
- c. That the Hon'ble Commission in the alternative may pass appropriate order in terms of Clause 12.1 of the EPA;
- d. The Respondent Undertaking be direct to reimburse the Petitioner of the losses including expenses and interest on loans incurred on the project from April, 2016 till date;
- e. The Respondent Undertaking be directed to release Rs.4.88 Crores outstanding towards the electricity invoices raised by the Petitioner;
- f. The Respondent Undertaking be directed to procure RE from the Petitioner's plant at Ahmednagar at the commission approved tariff with immediate effect.
