- a) *That necessary directions be issued to the Respondent to accelerate and complete the process of Installation of individual SEM at petitioner's generating station i.e. the Wind-Mill at Sadawaghapur, Satara.*
- b) *That Respondent be directed to not to cancel the O.A. permission dated 06.11.2017 on this ground.*
- c) *All other just and equitable reliefs be granted in favour of the petitioners for the effective adjudication of this case.*
