Subject:- Petition filed by Adani Electricity Mumbai Limited for adoption of tariff for procurement of upto 350 MW grid connected Wind-Solar Hybrid Power capacity with green shoe option of additional 350 MW grid connected Wind-Solar Hybrid Power capacity on long term basis through competitive bidding process to meet the Renewable Purchase Obligation.

- **Case No. 281 of 2019**

The Petitioner Adani Electricity Mumbai Limited has filed this Petition on 15.10.2019 under Section 63 of Electricity Act, 2003 for adoption of tariff for procurement of upto 350 MW grid connected Wind-Solar Hybrid Power capacity with green shoe option of additional 350 MW grid connected Wind-Solar Hybrid Power capacity on long term basis through competitive bidding process to meet the Renewable Purchase Obligation.

The main prayers of the Petitioner are as under-

- a) *To admit the Petition as per provisions under Section 63 of EA03.*
- b) *To accord approval for adoption of tariff for 700 MW wind-solar hybrid power with Rosepetal Solar Energy Private Limited for 25 years at price of Rs 3.35/kWh discovered in the e-reverse auction conducted on 04.09.2019 and the same to be made eligible for meeting the Solar and Non-Solar RPO requirement of AEML.*
- c) *pass any other order as may be appropriate under the circumstances.*
- d) *the Hon'ble Commission condone any inadvertent omissions / errors / shortcomings.*
- e) *the Hon'ble Commission may be pleased to permit the Petitioner to add or modify this petition with additional information, if so required during the course of hearings.*
