Subject:- Review Petition filed by ITC Limited under Section 94 of the Electricity Act, 2003 read with Regulation 85 of MERC (Conduct of Business) Regulations, 2004 of Order dated September 9, 2019 in Case No. 4 of 2019.

- **Case No. 284 of 2019**

The Petitioner ITC Limited has filed this Petition on 18.10.2019 under Section 94 of the Electricity Act, 2003 read with Regulation 85 of MERC (Conduct of Business) Regulations, 2004 of Order dated September 9, 2019 in Case No. 4 of 2019.

The main prayers of the Petitioner are as under-

- a. Review the Order dated September 9, 2019 in Case No. 4 of 2019 with respect to denial of relief pertaining to seeking direction against MSEDCL for purchase of unadjusted units for FY 2015-16;*
- b. Pass consequential orders directing Respondent No. 2 to purchase the unadjusted surplus units for FY 2015-16 and pay the Petitioner amounts due to them along with interest @18% p.a., calculated from the end of the FY during which the relevant units were injected into the grid within seven (7) days; and*
- c. Pass such other order(s) as the Hon'ble Commission may deem just in the facts of the present case.*
