Subject:- Petition filed by The Tata Power Company Limited – D seeking approval for adoption of Tariff discovered for Long Term Procurement of 150 MW Solar Power from Grid Connected Solar PV Projects through Competitive Bidding Process (Followed by e-Reverse Auction) for meeting the Renewable Purchase Obligation under Section 63 of the Electricity Act, 2003 read with Regulation 5 of the MERC (Terms and Conditions for Determination of Renewable Energy Tariff), 2015, Regulation 92 and 94 of MERC (Conduct of Business) Regulations, 2004.

- **Case No. 292 of 2019**

The Petitioner The Tata Power Company Limited – D has filed this Petition on 31.10.2019 seeking approval for adoption of Tariff discovered for Long Term Procurement of 150 MW Solar Power from Grid Connected Solar PV Projects through Competitive Bidding Process (Followed by e-Reverse Auction) for meeting the Renewable Purchase Obligation under Section 63 of the Electricity Act, 2003 read with Regulation 5 of the MERC (Terms and Conditions for Determination of Renewable Energy Tariff), 2015, Regulation 92 and 94 of MERC (Conduct of Business) Regulations, 2004.

The main prayers of the Petitioner are as under-

- a) *To admit the Petition as per the provisions under Section 63 of the Electricity Act, 2003;*
- b) *To accord approval for adoption of tariff as discovered in the competitive bidding process as mentioned in table under para 2.15;*
- c) *To accord approval for purchase of power for a period of 25 years and subsequent signing of PPA, with successful bidder for 150 MW;*
- d) *To accord approval to make this power eligible for meeting the Solar RPO requirement of the Petitioner;*
- e) *To pass any other order/relief as the Hon'ble Commission may deem fit and appropriate under the circumstances of the case and in the interest of justice;*
- f) *To condone any error/omission and to give opportunity to rectify the same;*
- g) *To permit the Petitioner to make further submissions, addition and alteration to this Petition as may be necessary from time to time."*
