

**NOTICE**

Subject:- Petition filed by M/s. Shah Lulla Estate Developers under Section 86(1)(f) of the Electricity Act, 2003 seeking direction against Maharashtra State Electricity Distribution Company Ltd. (MSEDCL) for (a) payment of interest in terms of Order dated 19.10.2018 passed by this Hon'ble Commission; (b) payment of outstanding payment (principal as well as interest) for power supplied from October, 2018 to March, 2019; and (c) payment of future invoices.

- **Case No. 285 of 2019**

The Petitioner M/s. Shah Lulla Estate Developers filed this Petition on 18.10.2019 under Section 86(1)(f) of the Electricity Act, 2003 seeking direction against Maharashtra State Electricity Distribution Company Ltd. (MSEDCL) for (a) payment of interest in terms of Order dated 19.10.2018 passed by this Hon'ble Commission; (b) payment of outstanding payment (principal as well as interest) for power supplied from October, 2018 to March, 2019; and (c) payment of future invoices.

The main prayers of the Petitioner are as under-

- (a) *Allow the present Petition;*
- (b) *Direct Respondent to make the payment of DPC amounting to Rs. 16,46,586.10/- for the payments made till 17.11.2018;*
- (c) *Direct Respondent to make the payment of Rs. 11,81,955- towards electricity supplied in the month of October, 2018 to April, 2019;*
- (d) *Direct Respondent to make the payment of the interest on delayed payments;*
- (e) *Direct Respondent to make payment of the electricity supplied by the Petitioner May, 2019 to August, 2019 amounting to Rs. 22,32,102.60/- (885755 Units);*
- (f) *Direct the Respondent to issue Credit Note within 3 days of the end of the calendar month and thereafter make payment of future invoices within due date; Alternatively, in case the Respondent fails to issue Credit Note within 3 days then direct the Respondent to make the payment to the Claimant on the basis of the meter reading by the Claimant (considering Reactive Energy consumption is zero);*
- (g) *Award costs of these proceedings against the Respondent and in favour of the Petitioner;*
- (h) *Pass such other further Orders as this Hon'ble Commission deems fit and proper in the facts and circumstances of the present case.*

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
