2. *Issue necessary directions to the Respondent to accelerate and complete the process of installation of individual SEM at Petitioner's generating station i.e. the Windmill S-32 and S-68 at Sadawaghapur, Satara and JTH-85 at Jath, Sangli.*
3. *Issue necessary directions to the Respondent to extend the validity period of MTOA permission for petitioners windmill S-32 and S-68 as applied and issue MTOA permission for windmill JTH-85 as applied.*
4. *Provide such other relief/reliefs which the Petitioner may be entitled to in facts and circumstances of this case for removing practical difficulties faced by the Petitioner in implementation to the provisions of the Regulation 17.8(a) of MERC (Distribution Open Access) (First Amendment) Regulations, 2019.*
