The Petitioner Zaveri & Co. Private Limited has filed the Petition on 14.10.2019 under Section 142 of the Electricity Act, 2003 for non compliance of MERC Order dated 01.01.2019 passed in MERC Case No. 143 of 2018 (Zaveri & Co. Private Limited seeking Order / Direction to Respondents to pay LPS (Late Payment Surcharge) for a sum total of Rs 45,94,975 (Rs forty five lakh ninety four thousand nine hundred seventy five only)

The main prayers of the Petitioner are as under-

- i. Direct the respondents to effect payment of LPS following the direction of this Hon'ble Commission and also pass an order for punishment for non compliance of the direction passed on 1/1/2019 with interest thereon.*
- ii. Direct the respondents for effecting payment of LPS in preference to any other payment to any other generating company and no payment to any other company be released till payment of the LPS.*
- iii. Impose such penalty and/or daily penalty on JVVNL under section 142 of the Electricity Act, 2003, as the commission may deem fit, for delay in payment of LPS beyond the date of order to the date of payment of LPS.*
- iv. Direction for cost of this petition be released apart from the LPS*
- v. any other relief which is just and proper may kindly be passed in favour of the petitioner.*
