Subject:- Petition filed by Maharashtra State Electricity Distribution Company Limited (MSEDCL) seeking approval for long term procurement of Baggase based co-generation power from the projects whose EPA with MSEDCL is expired / going to expire.

- **Case No. 321 of 2019**

The Petitioner Maharashtra State Electricity Distribution Company Limited (MSEDCL) has filed the Petition on 22.11.2019 seeking approval for long term procurement of Baggase based co-generation power from the projects whose EPA with MSEDCL is expired / going to expire.

The main prayers of the Petitioner are as under-

- a) *To admit the Petition as per the provisions of the Regulation 19 of MERC (RPO, Its Compliance and Implementation of REC Framework) Regulations, 2016.*
- b) *To accord approval for procurement of bagasse based co-generation power from projects which has completed EPA period of 13 years at Rs. 3.56 p.u. for further useful life of the plant.*
- c) *To accord approval that the energy purchased by MSEDCL is entitled for fulfillment of non-solar RPO target of MSEDCL.*
- d) *To consider the submission made by the Petitioner and consider the same positively while deciding the Petition as well as for further actions;*
- e) *To pass any other order/relief as the Hon'ble Commission may deem fit and appropriate under the circumstances of the case and in the interest of justice;*
- f) *Condone any error/omission and to give opportunity to rectify the same;*
- g) *To permit the Petitioner to make further submissions, addition and alteration to this Petition as may be necessary from time to time.*
