Subject:- Petition filed by B.P Marine Academy under Section 142 & 146 of the Electricity Act, 2003 for Non compliance of CGRF Bhandup Order No. 272/2018 dated 11 June 2019.

- **Case No. 318 of 2019**

The Petitioner B.P Marine Academy has filed the Petition on 19.11.2019 under Section 142 & 146 of the Electricity Act, 2003 for Non compliance of CGRF Bhandup Order No. 272/2018 dated 11 June 2019.

The main prayers of the Petitioner are as under-

a.) *The act and / or inaction on the part of respondent in their official duties are contrary to law, equity, good conscience and principles of natural justice.*

b.) *It's an duty of D.L (Distribution licensee) to rightly categorized the consumers as per their activity. But MSEDCL has taken the wrong action against them without any clarification or letters.*

c.) *We are also not comes under barred limitation as per U/S. 56(2) of E.A.2003 the tariff order comes into force in 2008 and till 2012 Hon'ble MERC revised tariff but instead of applying rite tariff to them , the D.L /MSEDCL has not complied the commission order 2012. So it is requested to punished the concern officer for the non compliance of Hon,ble Commission order u/s142 & 146 of E.A.2003*

a) *We also request Hon'ble Commission to give directive to concern officer i.e Superintending Engineer Vashi to comply CGRF Order or register our case as per provision of law u/s/142 & 146 E.A.2003 for non compliance of Hon'ble C.G.R.F. order.*

b) *It is also prayed that the compensation to the applicant be allowed for the harassment and compelling the applicant to carry out the work on his own by shirking away the direction of the Hon'ble CGRF order.*
