Subject: Petition filed by The Tata Power Company Limited Petition (Tata Power-T) seeking review of the Multi Year Tariff Order issued on the date 30.03.2020 (“Impugned Order”) by the Hon'ble Commission in Case No. 299 of 2019.

- **-Case No. 95 of 2020**

The Petitioner The Tata Power Company Limited (Tata Power-T) has filed this Petition on 23.5.2020 Petition under Section 94(1)(f) of the Electricity Act, 2003 read with Regulation 84 of the Maharashtra Electricity Regulatory Commission (Conduct of Business) Regulations 2004 seeking review of Order in Case No. 299 of 2019 dated 30th March, 2020 for Truing-up of ARR for FY 2017-18, FY 2018-19, Provisional Truing-up for FY 2019-20 and approval of ARR for the MYT 4th Control Period from FY 2020-21 to FY 2024-25 for Transmission Business of Tata Power

The main prayers of the Petitioner are as under-

A. *To allow the various points raised under Review petition as listed below:*

- a) *Removal of Income from Amortisation of Service Line Contributions from the Non Tariff Income (NTI) of Rs. 3.65 Crores and Rs. 2.43 Crores for FY 2017-18 and FY 2018-19 respectively.*
- b) *To allow surplus amount of Rs. 27.32 Crores as against approved Rs. 101.98 Crores for the total past recovery to be adjusted in FY 2020-21.*
- c) *To allow expenses of Rs. 4.08 Crores towards R&M expenses for FY 2018-19.*
- d) *Allow capitalisation of Rs. 0.43 Crores in FY 2017-18 towards Merged DPR scheme “Replacement of 22 kV and 33 kV Bus Sections at Carnac Receiving Station”*
- e) *To allow any financial implication arising out of the above Review to be considered during the MYT Petition.*
- f) *Pass such other order(s) as this Hon'ble Commission may deem fit and proper in the facts and circumstances of the case.*
- g) *Condone any inadvertent omissions/ errors / rounding off differences / shortcomings and permit Tata Power- D to add / change / modify / alter this filing and make further submissions as may be required at a future date.*
