Subject: Petition filed by The Tata Power Company Limited Petition (Tata Power-D) seeking review of the Multi Year Tariff Order issued on 30.03.2020 by the Hon'ble Commission in Case No. 326 of 2019.

The Petitioner The Tata Power Company Limited (Tata Power-D) has filed this Petition on 23.5.2020 Petition seeking review of the Multi Year Tariff Order issued on the date 30.03.2020 ("Impugned Order") by the Hon'ble Commission in Case No. 326 of 2019 for approval of Truing Up of FY 2017-18, Truing Up of FY 2018-19, Provisional Truing Up of FY 2019-20 and Tariff Projections for the Fourth MYT Control period from FY 2020-21 to FY 2024-25 for the Distribution Business of Tata Power (Tata Power-D)..

The main prayers of the Petitioner are as under-

- A. *To allow the various points raised under Review petition as listed below:*
- a. *Non-Consideration of Amount on account of the difference of actual UI amount paid to the UI Pool vs. UI amount received through various Tariff Orders while deriving the Past Gap / (Surplus) for Tata Power-D in this Order*
 - b. *Revised Revenue for FY 2017-18 without revenue from TOD tariff as it was already part of revenue from Energy Charges*
 - c. *Revised Revenue for FY 2018-19 without revenue from TOD tariff as it was already part of revenue from Energy Charges*
 - d. *Revised Income Tax computation considering revised Revenue for FY 2017-18, Revised revenue and expenses for FY 2018-19.*
 - e. *Cross Subsidy Surcharge for EHV Public Water Works for FY 2020-21 to FY 2024 25.*
- B. *To allow any financial implication arising out of the above Review to be considered during the MTR Petition.*
- C. *Pass such other order(s) as this Hon'ble Commission may deem fit and proper in the facts and circumstances of the case.*
- D. *Condone any inadvertent omissions/ errors / rounding off differences / shortcomings and permit Tata Power- D to add / change / modify / alter this filing and make further submissions as may be required at a future date.”*
